



### How to Keep Crud out of your Crusher

It matters. It matters enough that you want to invest in a cross-belt magnet to pull metal out of your process. It matters enough that you want an extra set of eyes checking for detritus in the material coming in for crushing.

If you think stray metal is tough on blow bars and wear plates, take a look at your belting after a piece of wood

has gone through the crusher. Imagine what those splinters are doing to the product that's supposed to meet a stringent spec. Watch out for plastic and pull those chunks out, of course.

First'

Tyke Van Zandt of FTG Construction Materials in Lodi, California, also warns producers and recyclers to keep an eye out for visqueen, which is a polyethylene plastic sheeting. He said that mess will wrap itself around everything that moves, eventually stopping everything from moving. That's a recipe for downtime.

As simple as it sounds, Van Zandt recommends, "Your main goal is to avoid feeding the crusher anything it wasn't designed to eat."
